
## What can the CGMA Finance Leadership Program offer me?

# How is the program structured?

#### How much does it cost?

Depending on your university, the CGMA FLP may be offered in one-, two- or three-year subscriptions. The cost of each subscription includes all learning, assessments, study materials, CIMA fees and exam fees.

#### How long does it take to complete?

How long you need to enrol for will depend on what level you enter the programme and how much time you're able to dedicate to studying. In certain situations, such as being enroled in a graduate program, you may be able to start the CGMA FLP at an advanced level and earn the CGMA designation even faster.

Once you've completed the CGMA FLP, you'll need to log three years of practical work experience before applying for your CGMA designation. CIMA will continue to offer resources and support you every step of the way.
