WORD BANK (Page 1 of 2)

ACCOUNTING - Recording and reporting of financial transactions, including the origination of the transaction, its recognition, processing, and summarization in the financial statements.

INTEREST - Payment for the use or forbearance of money.

BALANCE - Sum of debit entries minus the sum of credit entries in an account.

DEFICIT - Financial shortage that occurs when liabilities exceed assets.

YIELD - Return on an investment an investor receives from dividends or interest expressed as a percentage of the cost of the security.

CONSISTENCY - Accounting postulate which stipulates that, except as otherwise noted in the financial statement, the same accounting policies and procedures have been followed from period to period by an organization in the preparation and presentation of its financial statements.

ANALYST - Person who evaluates and interprets public company financial statements.

CONTROLLER - Experienced accountant who directs internal accounting processes and procedures, including cost accounting.

AUDIT - The inspection of a business or other organization's accounting records and procedures. Done by a trained accountant from within the organization or by an outsider for the purpose of verifying the accuracy and completeness of the records.

PRO RATA - Distribution of an expense, fund, or dividend proportionate with ownership.

PRO FORMA - Presentation of financial information that gives effect to an assumed event (e.g., merger).

CPA - An accountant who has satisfied the educational, experience, and examination requirements of his or her jurisdiction necessary to be certified as a public accountant.

BANKRUPTCY - Legal process, governed by federal statute, whereby the debts of an insolvent person are liquidated after being satisfied to the greatest extent possible by the debtor's assets.

REVENUES - Sales of products, merchandise, and services; and earnings from interest, dividend, rents.

PROSPECTUS - Major part of the registration statement filed with the Securities and Exchange Commission (SEC) for public offerings. This generally describes securities or partnership interests to be issued and sold.

TRUST - Ancient legal practice where one person (the grantor) transfers the legal title to an asset, called the principle or corpus, to another person (the trustee), with specific instructions about how the corpus is to be managed and disposed.

DEFAULT - Failure to meet any financial obligation, thus triggers a creditor's rights and remedies identified in the agreement and under the law.

ANNUITY - Series of payments, usually payable at specified time intervals.

DEPLETION - Method of computing a deduction to account for a reduction in value of extractable natural resources.

TAX - Charge levied by a governmental unit on income, consumption, wealth, or other basis.

CAPITAL - Assets intended to further production. The amount invested in a proprietorship, partnership, or corporation by its owners.

ESCROW - Money or property put into the custody of a third party for delivery to a grantee, only after fulfillment of specified conditions.

EXEMPTION - Amount of a taxpayer's income that is not subject to tax. All individuals, trusts, and estates qualify for this unless they are claimed as a dependent on another individual's tax return.

BUDGET - Financial plan that serves as an estimate of future cost, revenues, or both.

LIQUIDATION - Winding up an activity by distributing its assets to the appropriate parties and settling its debts.

REVENUES - Sales of products, merchandise, and services; and earnings from interest, dividend, rents.

EQUITY - Residual interest in the assets of an entity that remains after deducting its liabilities. Also, the amount of a business' total assets less total liabilities. Also, the third section of a balance sheet, the other two being assets, and liabilities.

WORD BANK (Page 2 of 2)

SPREAD - Difference between two prices, usually a buying and selling price.

CONSERVATISM - An investment strategy aimed at long-term capital appreciation with low risk; moderate; cautious; opposite of aggressive behavior; show possible losses but wait for actual profits.

LIABILITY - Debts or obligations owed by one entity (debtor) to another entity (creditor) payable in money, goods, or services.

FORECAST - Prospective financial statements that are an entity's expected financial position, results of operations, and cash flows.

LOSS - Excess of expenditures over revenue for a period or activity. Also, for tax purposes, an excess of basis over the amount realized in a transaction.

CFE (certified fraud examiner) - A specialist who is educated and trained in the detection and deterrence of a wide variety of white-collar crimes such as identity theft, fraud, and embezzlement.

PARTNERSHIP - Relationship between two or more persons based on a written, oral, or implied agreement whereby they agree to carry on a trade or business for profit and share the resulting profits.

MERGER - Business combination that occurs when one entity directly acquires the assets and liabilities of one or more entities and no new corporation or entity is created. Also known as a consolidation.

IRS - Part of the United States Treasury Department, this federal agency administers the internal revenue code.

PROJECTION - Prospective financial statements that include one or more hypothetical assumptions.

NEGLIGENCE - The failure to use such care as a reasonably prudent and careful person would use under similar circumstances; it is the doing of some act which a person of ordinary prudence would not have done under similar circumstances or failure to do what a person of ordinary prudence would have done under similar circumstances.

WITHHOLDING - Amount withheld or deducted from employee salaries by the employer and paid by the employer, for the employee, to the proper authority.

OPTION - Right to buy or sell something at a specified price during a specified time period.

GUARANTY - Legal arrangement involving a promise by one person to perform the obligations of a second person to a third person, in the event the second person fails to perform.

COMPILATION - Presentation of financial statement data without the accountant's assurance as to conformity, with generally accepted accounting principles.

FRAUD - The use of one's occupation for personal enrichment through the deliberate misuse or misapplication of employing an organization's resources or assets. This can include the fraudulent conversion and obtaining of money or property by false pretenses.

ACCOUNTANT - Individual who measures and reports economic events to help managers, investors, tax authorities, and others in making smart financial decisions.

PROXY - Document authorizing someone other than the shareholder to exercise the right to vote for the stock owned by the shareholder.

VARIANCE - Deviation or difference between an estimated value and the actual value.

SECURITY - Any kind of transferable certificate of ownership.

BOND - One type of long-term promissory note, frequently issued to the public as a security regulated under federal securities laws or state blue sky laws. These can either be registered in the owner's name or are issued as bearer instruments.

INSOLVENT - When an entity's liabilities exceed its assets.

MORTGAGE - Legal instrument evidencing a security interest in assets, usually real estate. These serve as collateral for promissory notes.

ACCOUNT - Formal record that represents, in words, money or other unit of measurement, certain resources, claims to such resources, transactions, or other events that result in changes to those resources and claims.
